

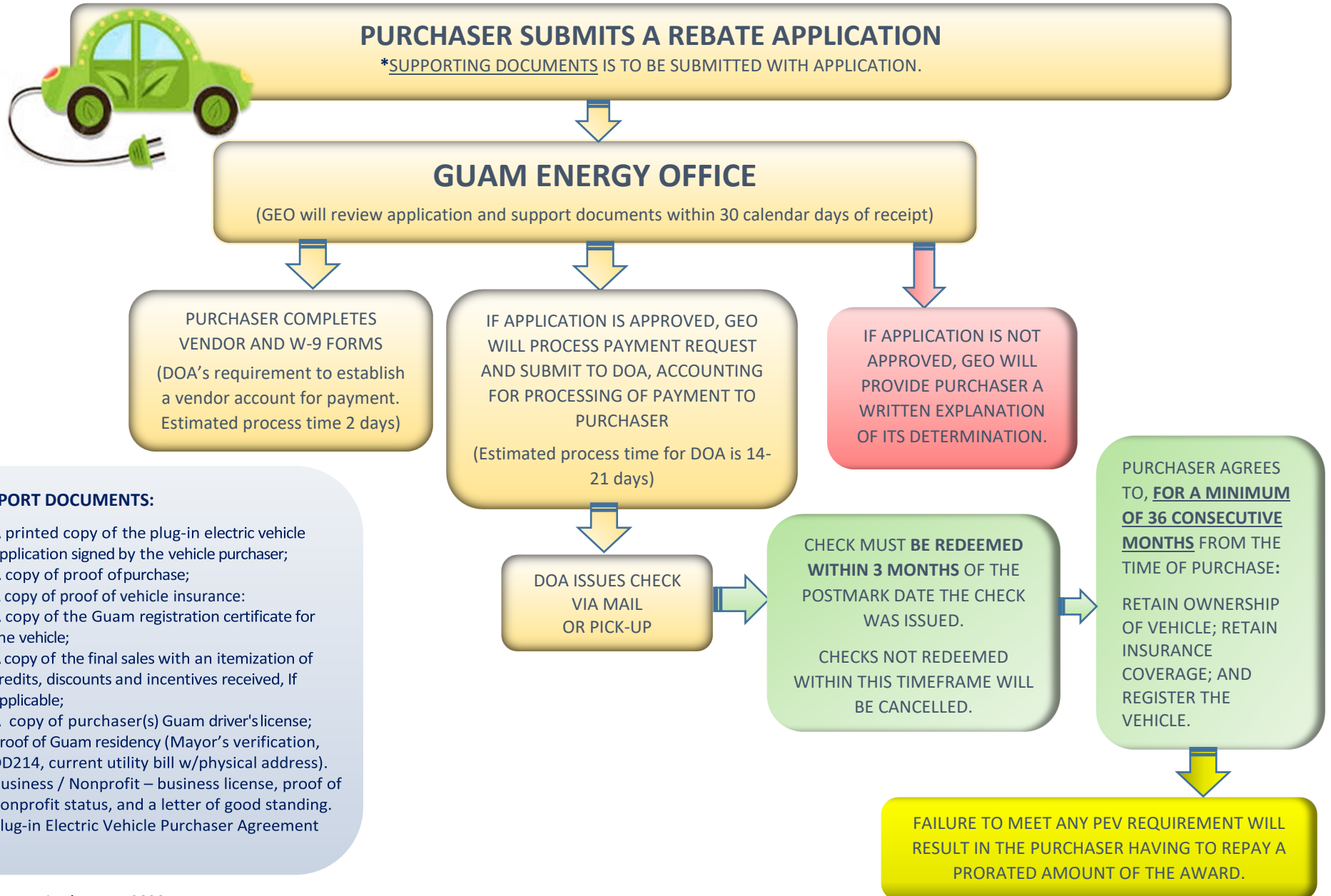

## How the PEV Rebate Program Works



### \*SUPPORT DOCUMENTS:

1. A printed copy of the plug-in electric vehicle application signed by the vehicle purchaser;
2. A copy of proof of purchase;
3. A copy of proof of vehicle insurance;
4. A copy of the Guam registration certificate for the vehicle;
5. A copy of the final sales with an itemization of credits, discounts and incentives received, if applicable;
6. A copy of purchaser(s) Guam driver's license;
7. Proof of Guam residency (Mayor's verification, DD214, current utility bill w/physical address).
8. Business / Nonprofit – business license, proof of nonprofit status, and a letter of good standing.

# GUAM PLUG-IN ELECTRIC DRIVE MOTOR VEHICLE REBATE PROGRAM

## APPLICATION FORM INFORMATION

The Guam Plug-In Electric Drive Motor Vehicle Rebate Program is a program locally funded and administered by the Guam Energy Office in order to promote the use of zero-emission vehicles that include electric vehicles. The program will financially assist individuals, businesses, and nonprofits by providing a rebate towards the purchase of a new plug-in electric vehicle. Funds are limited and available to purchasers on a first come first serve basis.

### **QUALIFYING PLUG-IN ELECTRIC VEHICLE REQUIREMENTS:**

- Must be a new vehicle with 4-wheels;
- Draws propulsion through a traction battery with a 4-kilowatt hours (kWh) of capacity;
- Use an external source of energy to recharge the electric vehicle's battery;
- A gross vehicle weight rating of *not more than* 14,000 pounds; and
- Meets specified emission standards

### **BEFORE YOU BEGIN**

Purchaser will be served on a first come first serve basis. Incomplete applications will be returned. You may resubmit a completed application, which will be processed in the order received, while funds last. If Purchaser is rejected, funds are not held until an application form is approved.

#### **1. ENSURE YOUR ELIGIBILITY**

- The plug-in electric vehicle must be new and purchased in Guam on or after **October 1, 2014**.
- Purchaser must have a valid driver's license
- Purchaser must be 18 years or older.
- Purchaser must be a resident of Guam.
- Business / nonprofit organization must have a valid business license, proof of nonprofit status, and in good standing.
- The plug-in electric vehicle must be registered under the Purchaser(s) name, business or organization.
- Proof of purchase for the plug-in electric vehicle.
- Proof of insurance for the plug-in electric vehicle.
- The plug-in electric vehicle must be purchased from one of our registered authorized dealers.

#### **2. PURCHASE A QUALIFYING PRODUCT**

#### **3. INCLUDE SUPPORTING DOCUMENTS WITH YOUR APPLICATION**

##### INDIVIDUAL PURCHASER

- A copy of your valid Guam Driver's License.
- A copy of Proof of Residency (e.g., Mayor's verification, DD-214, current utility bill with physical address).

**Con't. INCLUDE SUPPORTING DOCUMENTS WITH YOUR APPLICATION**

**BUSINESS / NONPROFIT ORGANIZATION**

- A copy of business license
- A letter of good standing
- Proof of nonprofit status

**ADDITIONAL SUPPORTING DOCUMENTS**

- Provide proof of purchase for the plug-in electric vehicle.
- Provide proof of insurance for the plug-in electric vehicle.
- Provide a copy of vehicle registration under the Purchaser(s) name, business, or nonprofit organization.

# GUAM PLUG-IN ELECTRIC DRIVE MOTOR VEHICLE REBATE PROGRAM PURCHASER AGREEMENT

## TERMS AND CONDITIONS

As a condition for receiving Guam rebate funds, you (the purchaser) must comply with the requirements below. You are responsible for reviewing the program requirements prior to applying for a rebate. Eligible purchasers must meet requirements that include the following, where applicable:

1. Be a resident of Guam. Proof of Guam residency will be required to complete the Guam Plug-In Electric Drive Motor Vehicle Rebate application.
2. Eligible vehicles must be purchased through our registered authorized dealers. Active duty military members with permanent residency in Guam are eligible to apply and may use military orders in lieu of other proof of residence documentation.
3. A business or nonprofit organization must be registered with the government of Guam and in good standing.
4. Submit to Guam Energy Office (GEO) a completed and signed rebate application.
5. Vehicle purchase date must be on or after October 1, 2014 (start of program).
6. Not make or allow any modifications to the vehicle's emissions control systems, hardware, software calibrations system.
7. Retain ownership of the vehicle for a minimum of 36 consecutive months immediately after the vehicle purchase date.
8. Retain insurance coverage of the vehicle for a minimum of 36 consecutive months immediately after the vehicle purchase date.
9. Register the new vehicle with the Department of Motor Vehicle (DMV) for a minimum of 36 consecutive months for use in Guam.
10. Submit a copy of the updated vehicle registration and insurance coverage for the next 2 years to GEO.
11. GEO reserves the right to request voluntary participation from rebate recipients in ongoing research efforts that support the Guam Plug-In Electric Drive Motor Vehicle Rebate Program goals.
